

Sub: - Issuance of notifications under Section 7 of the Aadhaar Act by the State Government for the schemes funded out of the Consolidated Fund of State.

Circular No. – 02 JK(ITD) of 2021
Dated: 17.02.2021

The use of Aadhaar as identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one's identity.

As per provisions in the Aadhaar and other laws (Amendment) Act, 2019, the State Governments can henceforth, mandate use of Aadhaar authentication for the beneficiaries under Section 7 of the Aadhaar Act 2016 in those schemes which are funded out of Consolidated Fund of the State and in order to do so, J&K UT Government will need to issue notifications under Section 7 of the Aadhaar Act, 2016 in respect of specific schemes, similar to the one as published by the Central Ministries/Departments.

As of now, 17 schemes pertaining to eight departments have been identified which are funded out of consolidated fund of the UT as per the DBT Portal of UT of Jammu and Kashmir (list of schemes is also enclosed as **Annexure-A**). Accordingly, it is impressed upon all the concerned departments to take necessary steps to issue notification under section 7 of Aadhaar Act 2016 of their specific schemes which are funded out of the Consolidated Fund of India/UT as per the attached standard templates.
