

Minutes of Meeting of the Selection Committee constituted vide Government Order No. 1401-GAD of 2016 dated 22.12.2016 held on 30.03.2021.

1) Aforementioned Selection Committee met under the Chairmanship of Shri Simrandeep Singh, IAS Secretary to the Government Department of Information Technology, Government of J&K. The following members of the Committee also participated in the deliberations;

- i. Shri Achal Sethi, Administrative Secretary, Department of Law, Justice and Parliamentary Affairs.
- ii. M.Y. Itoo, Director General (Budget), Finance Department.
- iii. Shri Rohit Sharma, KAS, Additional Secretary to Government, General Administration Department.

2) During the course of meeting, various provisions of SROs 343 and 344 dated 24.10.2016, dealing with J&K Information Technology (Gazetted) Service Recruitment Rules 2016 and J&K Information Technology (Subordinate) Service Recruitment Rules 2016, respectively, were read and discussed thoroughly along with Government Order No. 1094-GAD of 2016 dated 14.10.2016. It has been resolved that the Selection Committee will strictly abide by the mandate given in rule 4 of both the above referred SROs which reads as under:

“Selection Committee: The Government shall constitute a selection Committee in General Administration Department for appointing persons who have previously been appointed to various Departments/Services against the IT related posts in the initial constitution of the service.”



3) After thorough discussions on all aspects, following decisions were taken unanimously by the Committee:-

- iv. The Selection Committee decided that the first and foremost thing is to constitute the service by identifying the Initial constituents of the Service strictly as per the provisions of aforementioned SROs. In this regard, the Selection Committee authorized the Information Technology Department to collect the particulars of the eligible entrants by inviting their details

as per a format devised by the Information Technology Department. The particulars of the entrants/initial constituents shall be accepted only if the same are duly attested by the respective DDOs and countersigned by the concerned HODs. The same shall be required to be submitted within 21 days of the issuance of the notice by the Department of Information Technology Govt. of Jammu and Kashmir.

- v. It has also come to the fore that various prospective candidates are aggrieved with respect to miscellaneous anomalies and it was decided that their issues shall be taken separately subsequent to collection of service particulars of IT related personnel within the stipulated time frame as in para (i) above.
- vi. It was also decided that operationalization of IT service shall be examined from legal stand point. Thus, Law Officer of the IT Department will go through all the litigations having bearing on the constitution of the service and ensure that there is no restraint or bar either from the Hon'ble High Court or Central Administrative Tribunal (CAT) in this regard and shall apprise the Committee accordingly well in time.
