The Government of Jammu and Kashmir has embarked on an ambitious journey for ushering in the era of smart, efficient, responsive, transparent, citizen friendly and corruption free governance. A number of major IT initiatives have been taken in recent times by the UT Government of Jammu & Kashmir. These have brought about a paradigm shift in the structure of governance and the common people are beginning to feel this transformation to a forward looking, modern, people-friendly and empathetic government.

In order to highlight and popularize these IT initiatives and with the aim of making the common public 'partners in governance', the Government of the UT of Jammu and Kashmir has decided to organize the "Digital J&K Week" from 25th to 31st July 2022. In order to popularize the online services being provided by the Union Territory Government, all Departments to conduct sessions regarding their respective online services. The day-wise programme for participation in the Digital J&K Week at SKICC starting from 25th July, 2022 in respect of all departments is enclosed at **Annexure-A**.

The Departments shall ensure successful conduct of their sessions by considering the following:

- iv. Departments shall also ensure participation in virtual mode for the participants at the Division, District, Tehsil, Block level for which the link will be shared by SIO, NIC J&K.
- v. The event will be webcasted for which the link will be shared by SIO, NIC J&K.
- vi. Departments to record the proceedings of their respective sessions and will share recommendations with IT department for final compilation by 31st July, 2022.
