Terms of Reference:

1. The committee shall examine the project proposals viz-a-viz adherences to latest technological standards/advancements ensuring resource and cost optimization.
2. The committee shall also take note of circular instructions issued by General Administration Department issued vide Circular No. 17-JK(GAD) of 2024, in reference to Disaster Recovery (DR), Near-DR for J&K SDC and proposed migration of e-office to NIC cloud.
3. The committee shall ensure adherence to GFR guidelines specific to bid neutrality, participation of at-least three OEM(s) along-with compliance to all rules, procedure(s)/guidelines issued by the Government from time to time.
4. The committee shall examine the proposal with regard to inter-operability besides recommendations/suggestions on the viability of the proposed solutions.
5. The committee shall submit its report to the IT Department within 10 days from the date of issuance of this order.
