Whereas, in pursuance to Cabinet Decision No. 91/10/2016 dated 14.10.2016, sanction was accorded to the creation of the Jammu and Kashmir Information Technology Service vide Government Order No. 1094-GAD of 2016 dated 14-10-2016;

Whereas, in pursuance to Government Order No. 1094-GAD of 2016 dated 14-10-2016, the Jammu and Kashmir Information Technology Service Recruitment Rules, (Gazetted & Non-Gazetted) have been notified vide SRO 343 & 344 dated 24.10.2016 and;

Whereas, all the Information Technology related posts were withdrawn from the departments, (excluding the posts created under project/scheme sponsored by the Government of India, etc) and their inclusion in the Jammu and Kashmir Information Technology Service;

Whereas, 314 Information Technology related posts withdrawn were re-designated and 51 posts in different departments were abolished;

Whereas, out of the total posts re-designated, the following posts of Department of Law, Justice & Parliamentary Affairs were re-designated and;

Whereas, among the posts abolished, 03 posts of Data Entry Operators in the pay band (5200-20200+2400) of Department of Law, Justice & Parliamentary Affairs were abolished and;

Whereas, on the recommendations of General Administration Department, the Department of Law, Justice and Parliamentary affairs requested Information Technology Department for withdrawal/deletion of IT related posts of High Court out of the J&K IT service in view of the fact that

J&K High Court is the cadre controlling authority of IT related persons employed in High Court and in terms of Section 4 of the Jammu and Kashmir High Court staff (Conditions of Service) Rules, 1968, all the appointments to the staff of the High Court including promotion has to be made by the Chief Justice who may, however, delegate any of the powers of appointment other than those of the gazetted officers to the Registrar or to any judge of the High Court;

Whereas, on examination of the proposal in the Information Technology Department regarding withdrawal of the posts of J&K High Court, Information Technology Department requested the Department of Law, Justice and Parliamentary Affairs to take up the matter with General Administration Department for taking a final decision regarding withdrawal/deletion of IT-related posts of J&K High Court;

Whereas, the Department of Law, Justice and Parliamentary Affairs again took up the matter with General Administration Department. The General Administration Department in turn requested to take up the matter with Information Technology department being the Administrative Department of IT personnel and request them to take cognizance of GAD's advice as has already been conveyed vide U.O. No. GAD(Adm)96/2013-V dated 11.12.2018;

Whereas, after the examination, the matter has been taken up with the GAD for placing the same before the Establishment- Cum-Selection Committee for deletion/withdrawal of 23 IT related posts borne on the establishment of J&K High Court from Jammu & Kashmir Information Technology Service; and

Whereas, the Establishment-cum-Selection Committee held under the Chairmanship of Chief Secretary on 19.01.2021 recommended deletion of 23 IT related posts borne on the establishment of J&K High Court from Jammu & Kashmir Information Technology Service;

In view of the recommendations of Establishment-cum-Selection Committee, 23 IT related posts of Department of Law, Justice and Parliamentary Affairs borne on the establishment of J&K High Court are withdrawn/deleted from the purview of Jammu & Kashmir Information Technology Service ab-initio.




