Whereas, vide Executive Order No. 13-JaKeGA of 2021, dated: 29.01.2021, the earlier Technical Sanction granted to the aforementioned scheme, was cancelled by CEO, JaKeGA, with the request to the Administrative Department to cancel the Administrative Approval accorded to the extant scheme.

Whereas, vide OM No: JaKeGA/Gen/02/2020, Dated: 24.02.2021, Chief Executive Officer, Jammu and Kashmir e-Governance Agency, has furnished reasons for the non execution of the scheme that "The project was closed due to the lack of follow up/finalization of functional requirements/Nomination of nodal officer for the project/constitution of implementation team etc. from the principal user Department (JKTDC). Further, current Financial Year is at its fag end and hence the same cannot be implemented during this period".

Now, therefore, the Administrative Approval accorded to the scheme "Designing and Development of Technology Solution for Centralized Accounting/Billing/Inventory Management/ HRMS solution for J&K Tourism Development Corporation", vide Government Order No. 42-JK(ITD) of 2020, dated 04.09.2020, is hereby cancelled ab-initio.
