**Terms of Reference:**

2. The committee may also give its recommendations / suggestions on the proposed solutions in the DPR, along with the estimated cost projected in the DPR.
3. The committee may meet at one place or may give its recommendations by way of circulation of agenda. The coordinating Project Manager of JaKeGA shall be responsible for circulating the submissions to all committee members, if done in circulation mode.
4. However, whenever necessary the committee may decide to meet at an appropriate place subject to convenience of the members. The Committee may meet through online mode.
5. The committee may co-opt any technical expert at any level, subject to its wisdom.
6. The coordinating Project Manager shall be responsible to provide any additional information related to the solution / DPR to the committee.
7. In case of any conflict of interest, it will be the responsibility of the members to inform the Secretary to the Government, IT Department and withdraw himself from the committee on that particular issue/ point.

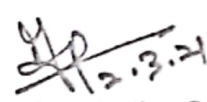
