Whereas General Administration Department (GAD) vide its communication No: Gad(Vig)06-Adm/2014-partfile, dated 10-02-2020, approached Information Technology Department, for *Design and Development of Online Vigilance Clearance System* for GAD.

Whereas, the draft Request For Proposal (RFP) for the said project was prepared by Jammu and Kashmir e- Governance Agency (JaKeGA), which was shared with GAD vide OM No. JakeGA/Gen/07/2020 dated 18-05-2020 and GAD vetted the draft RFP without any changes vide its OM No GAD(Vig) 06-Admin/2014-partfile, dated 17-07-2020.

Whereas the Technical Sanction was accorded to the project by CEO, JaKeGA vide Executive Order No 81-JaKeGA of 2020, dated 27-08-2020 and accordingly Administrative Approval was accorded by Information Technology Department to the extant scheme/project vide Govt. Order No 43-JK(ITD) of 2020, dated 08-09-2020.

Whereas, JaKeGA issued the work order for "Design and Development of Online Vigilance Clearance System for General Administration Department" vide letter No. JaKeGA/Gen/07/2020, dated 08.09.2020.

Whereas JaKeGA shared the Functional Requirement Specification (FRS) Document with GAD for its approval and go-ahead vide communication No. JaKeGA/Gen/07/2020, dated 25.09.2020.

Whereas, even after repeated requests made by JaKeGA regarding approval of FRS and goahead, GAD failed to respond.

Whereas, keeping in view the non-willingness of user Department (GAD) regarding the execution of the said project, the earlier Technical Sanction granted to the aforementioned project by CEO, JaKeGA has been cancelled by JaKeGA, vide its Executive Order No 29-JaKeGA of 2021, dated 16-03-2021, with the request to the Administrative Department to cancel the Administrative Approval accorded earlier to the said scheme/project.

Now, therefore the Administrative Approval Accorded to the project "Design and Development of Online Vigilance Clearance System for General Administration Department (GAD)" issued vide Government Order No 43-JK(ITD) of 2020, dated 08-09-2020 is hereby cancelled, ab-initio.
