

Subject: Bandwidth Connectivity through empanelled Internet Service Provider for various Offices using e-Office outside the Civil Secretariat - regarding

Government Order No: 43 - JK (ITD) of 2021  
Dated: 23.06.2021

- 1) Whereas the Government of J&K vide its order bearing number 363-JK(GAD) of 2021 dated 23.04.2021, issued instructions for implementing e-Office in various offices of the Heads of departments which are part of the bi-annual Darbar move (hereafter referred to as Move-HoDs); and
- 2) Where as officials nominated by the Move-HoDs were provided training by the department of Information Technology through trainers of JaKeGA & Railtel Ltd; and
- 3) Whereas these Offices were advised to seek connectivity for using office through NIC's NKN Intranet connectivity or through Virtual Private Network (VPN); and
- 4) Whereas in this while the Jammu and Kashmir e-governance Agency's bid for empanelling Internet Service Providers (ISPs), at State (read as UT level), District level and Block level for its various projects like State Wide Area Network (SWAN), Digital Village Project, eOffice redundant connectivity etc., got finalised that has provided an alternate source of connectivity for using e-Office; and
- 5) Whereas, the Points of Presence (PsoP) proposed to be established through the empanelled ISPs are indicated below:
  - i) State Head Quarter (SHQ) – Civil Secretariat Jammu/Srinagar.
  - ii) District Head Quarter (DHQ)- All DC Offices.
  - iii) Block Head Quarter (BHQ)- Various Block Offices.
  - iv) Digital Village Centres (DVC) – Identified Gram Panchayats under the pilot initiative.
  - v) Horizontal Offices – Various Horizontal Offices that are feasible in the above locations.
  - vi) Other Offices – Any other office of J&K Government that is feasible.

- 6) Whereas for the purpose of using e-Office secured Multi-Protocol Label Switching (MPLS) technology or VPN based Internet technology, as the case may be, has been proposed which will connect all the identified locations with the State Headquarter as well as with the State Data Centre; and
- 7) Whereas consequent upon the conclusion of empanelment process, the following rates have been arrived at for various technologies (MPLS / ILL / VPN):

- 8) Whereas the estimated bandwidth requirements for various Move-HoDs, who are interested in taking connectivity through above empanelled ISPs for eOffice, are indicated below-

**Note:** Concurrent users mean no. of users logged into e-Office at the same time. JaKeGA has worked out the concurrency at 50% of the total no. of the users of the department/office.

- 9) Whereas JaKeGA will get the feasibility of all interested Move-HoD offices checked from the empanelled bidders. If found feasible, JaKeGA shall inform the concerned Move-HoD about the cost (per annum) and the technology proposed for procurement of bandwidth. The bandwidth shall be provided / enabled by JaKeGA through its empanelled ISP only upon receipt of a confirmed Purchase Order along
